_____ MIDWESTERN AUTO SALVAGE has a no refund-exchange only return policy. If a replacement is not available a refund will be issued. We have a 30 day limited replacement guarantee on parts and MIDWESTERN AUTO SALVAGE extends no warranty towards the appearance of any parts. MIDWESTERN AUTO SALVAGE is not responsible for any labor charges. ALL PARTS ARE USED UNLESS OTHERWISE STATED. MIDWESTERN AUTO SALVAGE WILL NOT warranty any electrical item period. Electrical parts are sold as is with no expressed or implied warranty. This includes but not limited to ECUs, modules, distributors, coils, alternators, and starters.

_____ MIDWESTERN AUTO SALVAGE has a 30 day limited warranty on drivetrain components. Engine warranty only covers the longblock assembly. This only covers the engine block, rotating assembly(i.e. crankshaft and pistons), and cylinder head(s). Oil pans, timing belts/chains, water pumps, throttle bodies, injectors, sensors, and intake/exhaust manifolds are not considered part of the longblock assembly and are not guaranteed. We do no warranty seals or gaskets on used engines and transmissions. It is the Buyer's responsibility to replace gaskets, seals and accessories before installation. MIDWESTERN AUTO SALVAGE under no circumstance is responsible for labor, freight, or any other costs associated with the purchase of used drivetrain parts. In the instance where a refund is granted to the Buyer, only the purchase price of the part will be refunded minus any original shipping charges or fees.
